Greetings,

As our Worshipful Master observed, this Masonic year approaches its conclusion. As we reflect on the experiences we have shared, it is important to evaluate our successes (so that we may repeat them) and our weaknesses (that we may improve ourselves). As such, I have been ruminating on the disappointing "tuxedo night" which was hosted early in our year and working on a plan to move forward with a far more successful do-over of this event. My commitment to this is such that I am dedicating my portion of the bulletin to nothing BUT a new and improved tuxedo night!

What I ask from you brethren is your opinion on which path forward I should steer us toward. The first (Macways.com) is <u>significantly</u> more cost effective, but likely slowest, as suits would be measured at Lodge but assembled and shipped from Bangkok, Thailand. They would be directly shipped to your preferred address, and prices are advertised as \$370 for a tuxedo suit, \$70 for a Tuxedo shirt, and \$420 for a three piece suit (with vest). The second (Tomjames.com) is the "bespoke" option with fitting at Lodge or a location of your choosing and with a far greater selection of styles and options. But these suits <u>start</u> at \$699.

So, if you are interested in ordering a tuxedo or a new suit, please reach out to me with your preference. Please note that either of these vendors are available for individual fittings should you choose to deal directly with the vendor. My aim is to arrange a discount price for our "group buy," but I can't negotiate that until I have a barometer for the overall interest of this future event.
